**DISSERTATION ABSTRACT:** Reacting to increased competition, companies are adopting interorganizational information systems (IOS) that share information across the supply chain partners. Trust, an implicit requirement of an effective inter-organizational information system, can be explained by four major environmental factors: transaction cost economics, power of the organization in the channel, institutionalization and the level of integration. We have developed a framework to understand the environmental explanations to the level of trust between partners on the basis of the above four factors.
