5. Admissions Criteria

Criteria

Standards for admission to the Doctor of Philosophy in Business Administration are based on multiple sources of evidence of an applicant's qualifications, commitment to the program and are comparable to those for doctoral programs in other disciplines in other universities. All applicants must hold a bachelor's and master's degree from a regionally accredited United States institution or a recognized international equivalent.

Applications in Ph.D. in Business Administration with concentrations in Management and Marketing are accepted every even years whereas applications with concentrations in Finance and Information Systems are accepted every odd years Interested individuals need the following to begin the admission process:

- Completed Application form submitted to http://www.utrgv.edu/graduate/onlineapplication/index.htm
- GMAT/GRE valid score
- Official Transcripts for all colleges and universities attended
- GPA of 3.0 or higher
- 3 letters of recommendation from academic sources
- Submission of a personal statement describing goals, experiences, scholarly accomplishments, reasons for obtaining the degree, and possible research questions or topics of interest.
- Submission of resume or curriculum vitae

There are additional requirements for **international applicants**:

- TOEFL passing score of 550 for the paper test and 79 for the Internet-based test for foreign applicants from non-English speaking countries
- English Translations of educational records
- Financial Documentation
- Immigration Documents
