

ne purpose of the tuition rebate program is to provide a financial incentive for students to prepare for university studies while ompleting their high school work, avail themselves of academic counseling, making early career decisions, and complete their accalaureate studies with as few courses outside the degree plan as possible. Minimizing the number of courses taken by students sults in financial savings to students, parents, and the state.   Iigible Students  Deferolled for the first time in an institution of higher education in the fall 1997 semester or later  Request a rebate for work related to a first baccalaureate degree received from a Texas public university  Been a resident of Texas, must have attempted all coursework at a Texas public institution of higher education, and have been entitled to pay resident tuition at all times while pursuing the degree  If enrolled for the first time in fall 2005 or later, graduate within four calendar years for a four-year degree or within five calendar years for a five-year degree if the degree is in architecture, engineering, or any other program determined by the Texas Higher Education Coordinating Board to require more than four years to complete, and  Attempted no more than three hours in excess of the minimum number of semester credit hours required to complete the degree under the catalog under which they were graduated. Hours attempted include transfer credits, course credit earned exclusively by examination (except that, for the purposes of this program, only the number of semester hours earned exclusively by examination in excess of nine semester credit hours is treated as hours attempted), courses that are dropped after the official census date, for credit developmental courses, optional internship and cooperative education courses, and repeated courses. Courses dropped for reasons that are determined by the institution to be totally beyond the control of the student shall not be counted.
