Pathways Document Overview

This document provides key deadlines for the completion of the review at each respective level, however, subsequent reviews can begin as soon as the file is advanced. Faculty are encouraged to submit their response to the review as soon as they receive it but within no more than 10 business days. Each review level will auto-advance to the next stage at the deadline if not manually advanced by the faculty member. Once the dossier is advanced, either by the faculty member or automatically, the decision cannot be reconsidered by the previous level.

The Pathways for the Health Colleges (College of Health Professions, School of Nursing, and School of Social Work) deviate from the Academic Colleges in the following cases:

- Annual review for tenured faculty
- Annual review for tenure-track faculty years 3 and 5
- Annual review for non-tenure track (lecturers and clinical) faculty
- Reappointments (renewals) and promotions for non-tenure track faculty

You will find the timelines for these delineated within the section for each respective rank.

Note on committee formation:

Department and college committee members will be requested by the Office of the Provost in the spring for the following academic year. **All committees are to be finalized by May 1**, including selection of the committee chair.

*Candidates going up for Tenure & Promotion to Associate Professor in the next academic year, must submit External Review request to the Department chair no later than **March 1**.*

*In abiding by the deadlines above, a tenure-track faculty member may apply for tenure and promotion earlier than the beginning of the sixth academic year of the probationary period if the faculty member believes their performance record **substantially exceeds** the department's evaluation guidelines for tenure and promotion. Any conversation related to what "substantially exceeds" the evaluation criteria should be directed to the chair and/or dean.*
