a) New Program Development Team

Dr. Saenz gave an update on the New Program Development Team since the last meeting. The team reviews any new major or certificate which need to be approved by the team before it can be moved forward for external approval. During the most recent meeting, 5 new program ideas were approved. The new approved program ideas include:

- Bachelor of Music Business Entrepreneurship
- Bachelor of Music Music Technology
- Bachelor of Music Composition
- MFA in Graphic Design
- Post Bac Certificate in Communication Science and Disorders

Dr. Saenz also want to include this topic as an agenda item to provide updates on where the external approvals stand, what the steps are and how long they take.

b) Institutional Graduation Requirement

Dr. Saenz discussed am email regarding a Black Lives Matter taskforce that has been formed by a group of faculty members, not an institution designated taskforce. She was asked by Stephanie Alvarez what steps to take to include an approved graduation requirement that would impact all students. They are proposing identifying or developing courses that would expose students to diversity and ethnic issues. This would not be an additional course but would designate course(s) that meet a requirement to graduate with this diversity flag. The recommendation is that this needs to have a campus wide endorsement since it will impact all students. Feedback from the Committee, College and impacted programs is also requested. Discussion about what area the course would reside was discussed. Endorsing this idea, how it is implemented, making sure this does not increase time to degree and being mindful of the different populations.
