D. Informational Items

Service Learning and Internship Definitions, presented by Nick Weimer.

- -UTRGV is planning to become a Carnegie Foundation Community Engagement Classification university. UTB had this classification previously.
- -In order to obtain this classification faculty will be encouraged to add a service-learning component to their courses.
- -Faculty who are interested need to fill out an application form to obtain service-learning designation for a certain course. This will be reviewed and approved by ES&L (Engaged Scholarship & Learning).
- -Opportunities for faculty will be listed on website called "Engagement Zone".
- -For students to get credit it will be necessary to document hours of volunteer work.
- -Students can also do internships, a minimum of 25 hours per credit hour of internship will be required amounting to a minimum of 75 hours for a 3hr internship course. Anything less than 75hrs would be considered service learning.
- -ES&L will develop an internship portal that presents opportunities.
- -There is a plan to have a coordinator for each college for organizing internships and service learning activities.
