Meeting called to order at 12:15 by Dr. Brown

- I. Introduction: Dr. Cynthia Brown. Dr. Brown welcomed the committee members, Deputy Provost Office staff, and visitors. She described the nature of the committee's work this Spring semester as being focused on making revisions and corrections to the undergraduate curriculum that will be effective next academic year or that are required for accreditation. She also explained that current committee members will be reappointed in the fall semester with staggered terms. The committee is no longer considered "ad hoc."
- II. Election of Officers: Dr. Brown conducted the election. Dr. Downey-Adams self-nominated for the Chair position. Dr. Margaret Graham self-nominated for the Secretary position. Each was approved by unanimous vote. Dr. Brown turned over the meeting to Dr. Downey-Adams.

Motion (Dr. Brown) about operating procedures: Allow Deputy Provost office to make non-substantive changes (e.g., correcting course numbers or typos) to CIR and DPAR forms without having to returning form to department for approval. Motion to approve: Downey-Adams; seconded: Graham. Vote: in favor—7; opposed—0.
