- 2. Reminder: UTB-TSC/UTPA Legacy degree plans will only be honored through August 2019. Any legacy teacher preparation degree plan will end December 2017.
- 3. Reminder: The syllabus (with cross-listed undergraduate and graduate level coursework) must distinguish the graduate from the undergraduate course by showing a distinctive higher level expectation for the graduate level course.
- 4. The College of Education has two levels for graduation. A student graduating under the 126 hour degree plan will graduate certified. A student graduating under the 120 hour degree plan
