### D. INFORMATIONAL ITEMS

### 1. Department of Electrical and Computer Engineering

- Prerequisites clean-up on ELEE and CMPE courses to include a minimum grade of C on prerequisites listed due to ABET accreditation.
- This is an example of some of things that were discovered through the technical review process that could be streamlined and improved.
- Going through a clean-up of course inventory as part of accreditation review and noticed a discrepancy
   Grade of C or better was not included
- System does not automatically catch students that don't meet the "C or better" pre-requisites. Best that registrar's office can do is give department a report of students who are not meeting the requirement. Criselda from Registrar's office confirmed that this is the case. As soon as grades post, this list is sent out to the colleges and then colleges let registrar know if students need to be dropped. Some colleges want to review each case, others want registrar to just automatically drop.

## 2. Department of Mechanical Engineering

- Clarification on prerequisites and co-requisites of MECE 2301.
- In looking at Course Inventory file there is a column that says "Pre or Co requisite" and another that just says "Co-requisite". When a course is listed in the "Co-requisite" column, it is a must that student is concurrently enrolled. If listed in "Pre or Co" student can be concurrently enrolled or has previously taken course. MECE 2301 was listed incorrectly so many waivers were having to be processed.
