- Sheila Dooley presented to the committee an update on the ongoing discussion surrounding the current Language Proficiency graduation requirement for all degree plans. Only $20 \%$ of students actually meet this requirement by taking courses. Most test out or come in with transferred credits. Dr. McHatton stated at Town Hall that this is a compliance issue to require 6hrs above the 120 hours for the degree. Faculty are confused as to why this is now a compliance issue when we have been doing this for 3 years now. Suggested to include this in the Core but THECB has not allowed this. Primary issue as presented by Dr. Dooley is that if UTRGV is going to be a global university and stay true to its mission, this is something that we need to have. Discussion will be continued.
