1. School of Medicine

- a. Course Inventory: ADD INTM 6350 Directed Study in Bioethics
- 3 credit independent study
- Will allow student to get a proposal together for independent research and get through Institutional Review Board
- Allow the student to do in depth work, an in-depth systematic review
- It would also allow students that want to do a in depth study together, it is a good way for students to get that core information so they could do a quality capstone project.

3. College of Liberal Arts

- This Master of Science is based off the clinical psychology, PhD, that was approved by the curriculum committee years ago.
- PhD proposal called for an enroute master's degree
- First 30 hours of the Ph.D. program. NO additional faculty will be needed
- Teaching assistant (qualified) will help faculty with the teaching load
- After degree completion they will go on for additional training and in the PhD in clinical psychology
- Completion of MS and then they finish the rest of the courses and the PhD in clinical psychology
- Thesis correction Thesis I & Thesis II
- This is research intensive when students finish this program, they will not be able to go the clinical route

Clinical Psychology

• Is there any overlapping (Sbin)?

- There is no overlap. The courses in this masters are the courses that the PhD students have taken. The courses in the master's program are separated at a different level. (Cantos)
- The courses you described (see proposal) as part of the 30-hour program that are already existing course that they are taking already on the PhD program, is that correct? (Razo)
- Yes. (Cantos)
- If students do not pass the qualifying exam in PhD level, they will get masters? Do you have qualifying exams the PhD program? (Yanev)
- Yes, if they fail subsequently, they do not get an A or B, if they failed any other aspects like the
 qualifying exam then they would need to pass in order to be able to continue on to the doctoral
 dissertation. (Cantos)
- Will this proposal go through another level of approval? (Zemrani)
- Yes, it will go through UT System for approval. A full proposal needs to be developed before
 going to UT System. It will be a stand-alone master's program and it will be a Master of Science,
 as opposed to the current Master of Arts in Clinical Psychology. (Grewal)
- If I was graduating with a Master of Science in research intensive Clinical Psychology, I applied and got accepted by the PhD in Clinical Psychology what coursework of what product should I do to get my PhD? (Sibin)
- You will have to take all the 8000 level courses. 96 credit hours for the PhD 30hrs from their master's will go towards their PhD. (Cantos)
- Instead of the GRE we would like to do a more holistic assessment. (Cantos)
- Question will be raised because UT System would want us to justify. A strong case would need to be presented. (Grewal)
- To change that admission requirement (remove GRE) they would have to go through processes and through curriculum as soon as possible because admission requirements require several levels of approval and then must be posted for a year before it can be implemented. (Hansmann)
- I would need to fill out the form to change the admission requirement for the PhD program for your next meeting. (Sale)

- Yes. (Hansmann)
- Could we approve the proposal as presented and leave the question of the GRE open? (Zemrani)
- We are in a time crunch to get it to UT System. If we send it to them without the GRE, we can expect a delay in the system approval because they will ask a significant number of questions and they will demand data. Showing that students who do not take the GRE are as successful as the students who have or at least be successful in the program. (Shupala)
- Vote on the item as presented with the understanding that before it is routed to the higher levels that the GRE will be updated. (Hansmann)

- Team of 3 individuals who will assist me to look at any of the proposals that come in both for the Graduate College Committee or the undergrad committee
- We will maintain in helping the Grad College with maintaining their graduate catalog maintaining the curriculum review process.
- On the undergrad side, we are looking at articulation agreements
- Coordinate with the registrar's office from our degree works team etc.
- Thelma will be maintaining the course inventory collaborating with the grad college from the grad inventory to ensure that the course data we report to the coordinating board, the course data that we have in banner, and data in our web based digital catalog are all aligned.
- Our office is going to serve as the receiving office for all curriculum proposals however, on the grad side I will be collaborating directly with Sandy (Dr. Hansmann).
- My (Saenz) role is to advise, guide and facilitate the curriculum process. To serve as a repository for the
 institution of all changes that are coming through and document. The colleges do not have to have doubts to get
 answers they can ask our office.
- This office is not intended to be a barrier to innovation

- Taking additional work in terms of new program development and reporting programs externally
- This is to make sure that our accrediting bodies are notified in a timely manner of anything new that we are doing. Helpful for those faculty that are developing new programs

- Guide faculty through the development process and have them understand the timeline
- Help streamline the process and make sure when the proposal leaves campus it addresses any kinds of questions that might be raised by UT System for by the coordinating board or SACSCOC
- Any proposal we go to your office first before the Graduate College? (Zemrani)
- We have a new web-based platform for receiving so we will not be using email and sending PDF forms
 anymore. We have adopted a new system which will increase transparency across the institution. It provides a
 dashboard for everyone to see everything that is going on. Both Sandy and I will have the same access to
 review them.
- One immediate goal is to approve the process for fast track undergrad to grad programs. We are hoping this committee will join the undergrad committee at their November 13 meeting so we can have a policy that has been drafted and just need the blessing of the undergrad and grad committee together to implement this.
- Goes for both committees is we need to look at the stacking or the cross listing of undergrad and grad courses.
 It has been placed on hold because we do not have a process for approving that
- How we treat special topics courses, equivalent courses, zero credit hour courses and repeatable courses
- Any program even an existing program that is going distance education, which is off campus for online does need approval by the coordinating board or at least a notification to the coordinating board.
- Admission changes need Board of Regents approval and must be publicized, at least for one year before it can be implemented
- Degree Works
- It is taking your paper, pencil degree plan and putting it into a platform that allows you to evaluate whether students have completed all the courses that are in the program of study.
- The goal is Fall 2021 active catalog will be going live with degree works for graduate programs
- Degree Works is not only going to serve as an audit
- The shift especially for graduate programs is that it is going to be used to evaluate whether students should receive financial aid for the course that they are taking
- Degree Works is coded with all possible electives and it will be based on the catalog
