Dr. Wael Aguir mentioned the compliance rules of state board and mentioned that when receiving outside students with equivalent courses these are being taking in consideration.

Dr. Sibin Wu moves to approve changes and conversation will continue with Graduate College about the setup of leveling courses.

 - i. Civil Engineering proposal was previously approved by the Graduate Curriculum at the May 2020 meeting.
