Student's Justification for the Substitution Request:

Blanket substitution to allow students on VCoBE degree plans to use INFS 2398 as a substitute for QUMT 2398 as long as they meet the following conditions:

1. Student completes INFS 2398 with grade of "D" or better beginning Fall 2015 thru Summer 2 2016 regardless of catalog year; or
2. Student completed INFS 2398 with grade of "D" or better during any semester and completed at least 1 credit beginning Fall 2015 until Summer 2 2016 (making them eligible for the 2015-2016 Academic Catalog). This substitution would be processed manually upon or before application for graduation review.

Department's Justification for Approval/Denial:

Course content meets degree requirements.

1. Students who complete INFS 2398 beginning Fall 2015 until Summer 2 2016 completed the course as part of the General Education Core, course was listed as an option in the General Education Core Category 090.
2. Students who completed at least 1 credit beginning Fall 2015 until Summer 2 2016 are eligible for the 2015 Academic Catalog. There are several reasons that students may be eligible for the 2015 Academic Catalog but declared in the future catalog years.
