I. Convene Meeting

Start at 2:06 pm – 66/74 senators attended the zoom meeting

II. Guests

- A. Dr. Guy Bailey: 2:50 pm
 - a. Clarification: Leadership Cabinet. It is new group involved in making decisions for a broader departments/colleges' perspectives to make good decisions – such Commencement 2020 or budget issues, how to bring people back to work (broad

university decision). Leadership Council is not new, it is for information sharing/communication.

- b. Thanks everyone and all faculty for adjusting to Fall 2020 under the circumstances from the bottom of his heart
 - i. Discussion:
 - 1. Positive results: Increased enrollment & retention rate (student success)
 - 2. Preserve jobs and keep employment at UTRGV
 - 3. UTRGV gave back 10% of the annual budget
 - 4. Financial aid & COVID money package good in Fall
 - 5. Spring release package for our students (next 3 weeks)
 - 6. Pandemic effect for the next 2 years in the planning
 - 7. Mask & social distancing discussions for the student's wellbeing
 - 8. Course modalities for Spring 2021 & student online preparedness
 - 9. Increase faculty if you have an increase enrollment (>5% -= hiring faculty for the demand).

- B. Dr. Janna Arney: 2:40 pm
 - a. Clarify and review the structure of shared information across all divisions to allow it to be better reflected.
 - b. Faculty concerns for Dr. Janna Arney:
 - i. Communication Faculty Senate to other faculty (was not done well) need to come up with a way to communicate with all UTRGV faculty
 - ii. Early feedback: lack of motivation/synch course delivery = engagement (help the students to take online course with training)
 - iii. Budget for conference registrations (not for traveling) but online conferences?

III. Report of the FS President

Senator Cynthia (President) is welcoming everybody for the first meeting of the academic year.

- Dr. Arney is welcome to come to all our meetings as is President Dr. Bailey to attend and address the faculty for 10 minutes at each meeting. If any senators have any questions for the President – we invite you to send the question(s) to Cynthia or any of the FSEC members, so he has time/preparation if you need data. Cynthia suggested at least one week in advance, so the President has time to prepare.
- Senator Cynthia is reporting the Interim Provost Dr. Arney has organized a series of groups that
 will be meeting throughout the academic year. The FSEC requested to the President to have the
 Faculty Senate to be represented at higher level committee or meetings/groups meeting. As a
 result, Cynthia gave a brief review of summer meetings (PowerPoint presentation by Cynthia) –
 will be sharing on Blackboard for senators to consult after obtaining the last version of Dr.
 Arney.
 - Leadership Council meet once a semester to share institutional news and information, share priorities, successes, and priorities. Schedule for October. Membership: all

directors and above & FS (president & president-elect to be present at the meeting was recommended by Volker), staff senate, WFN and SGA representation.

- Leadership Cabinet meet 3 times per semester with the purpose of sharing
 institutional news and information, sharing priorities, successes and opportunities,
 cross-divisional information sharing, and relationship building and seeking feedback.
 Schedule: September 10, October 13 and November 17, Harlingen. Membership:
 President and VPs and Deans and elected representatives: FS, Staff Senate & WFN.
 - Talking about graduation for Fall 2020 and maintaining safety standards (diploma/picture) on both campuses.
- Provost's Council meet once a month or as needed to serve as Interim Provost's advisory group on institutional priorities including divisional policy approval and divisional strategic priority setting. Membership: VPs & Deans (divisions representations) & FS, WFN and ad-hoc members such as COLTT, library, CIO. (No more academic affairs executive committee)
 - Senator Firat raised a concern on: information sharing committees rather than decision making committee at the Provost's Council but wish to be part of the decision making at the other 2 levels.
 - Cynthia brought concerns about not having good communication with upper administration such as the budget/priorities
 - o Senator Bruno raised concerns to be talked to versus to speak with
 - o Senator Volker raised the importance of being at the table in those committees
 - Senator Mircea is reminding us the Senate does not participate in the decisionmaking steps. The Senate is the dog that gives university administration serving the goals and interests of the faculty, but in the taking of decisions.
- Deans and Chairs meet twice a semester to serve as advisory group on college specific priorities and issues. Not for us.

Since the summer we have been meeting sometimes weekly or every other week.

- Information sharing vs decision making questions concerns about being talked to or being part of the conversation
- DISCUSSION of the draft policy recommendations by UTRGV FSEC
 - o "Accommodating the Effects of COVID-19 for Faculty Reviews & Evaluations"
 - Adaptive Adjustment of Expectations
 - Extension until 1 year but need to ask for it
 - Annual Review Committee should demonstrate the flexibility to evaluate a candidate (adaptive effect approach)
 - FSEC will send it to all deans/faculty
