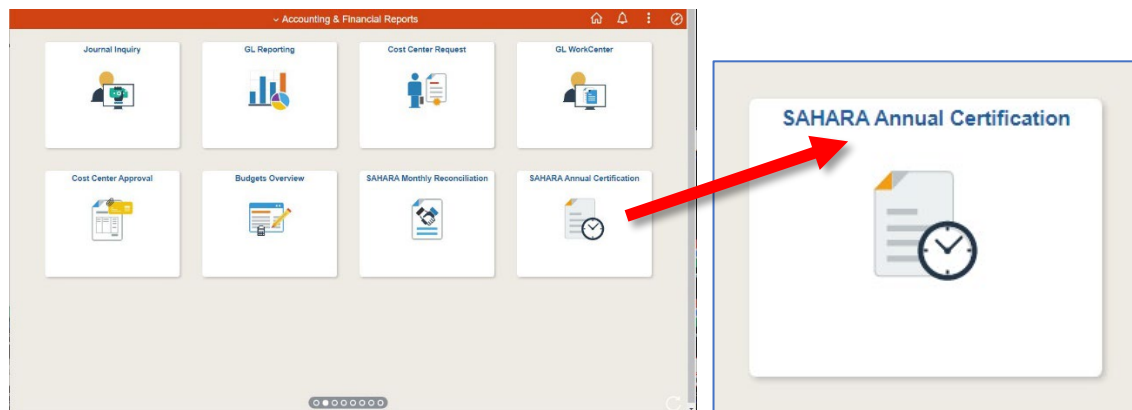
1. Login to PeopleSoft 9.2



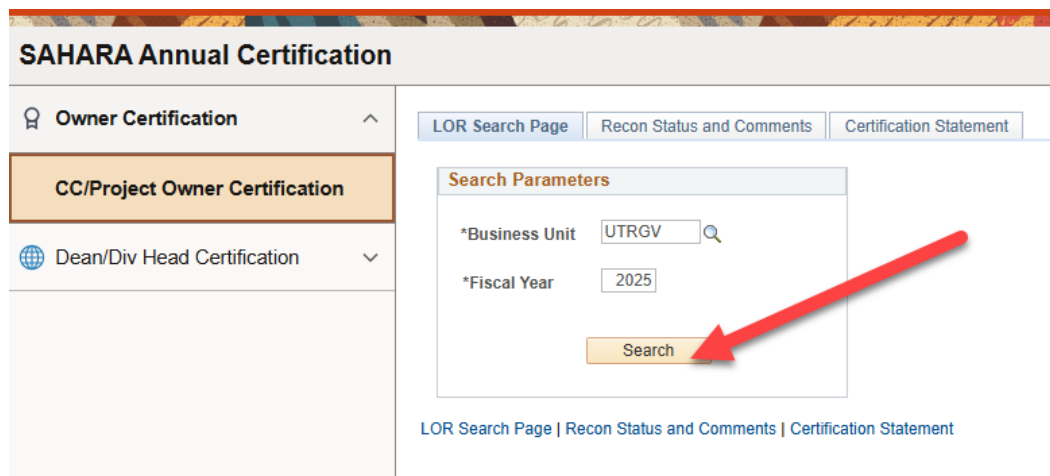
2. Navigate to **Accounting & Financial Reports** (you may use the Employee Service Drop down)



3. Locate & Click on the **SAHARA ANNUAL CERTIFICATION** tile



4. The CC/Project Owner Certification page will appear. In the center workspace, you will see three tabs (LOR Search Page, Recon Status and Comments, and Certification Statement). The Search Parameters are pre-loaded. Click on the **Search** button.

I understand my responsibilities for establishing and maintaining effective internal controls, and my requirement to report all suspected fraud. To the best of my knowledge, there has been no:
 - Fraud involving any employee that has not been appropriately identified and investigated; or
 - Fraud involving others that could have a significant effect on the financial statements that has not been appropriately identified and investigated.

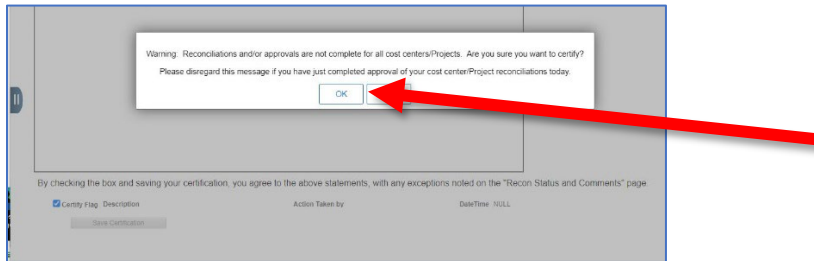
11. To certify, locate the **Certify Flag** check box and click on that check box. A check mark will appear inside.

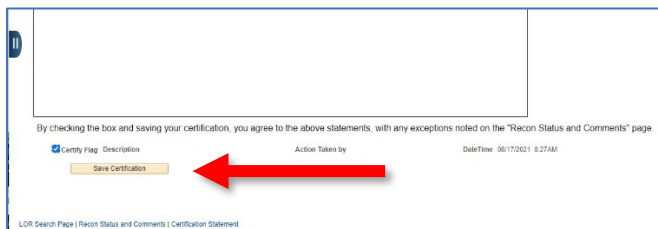

12. If you have any Cost Centers or Projects not yet reconciled nor approved for any period, a pop-up message will appear. This means that you are not ready to submit and lock your certification. Go to step 13. If this screen does not appear, it means you are ready to submit your certification; proceed to step 14. Click on the **OK** button to make the pop-up disappear.



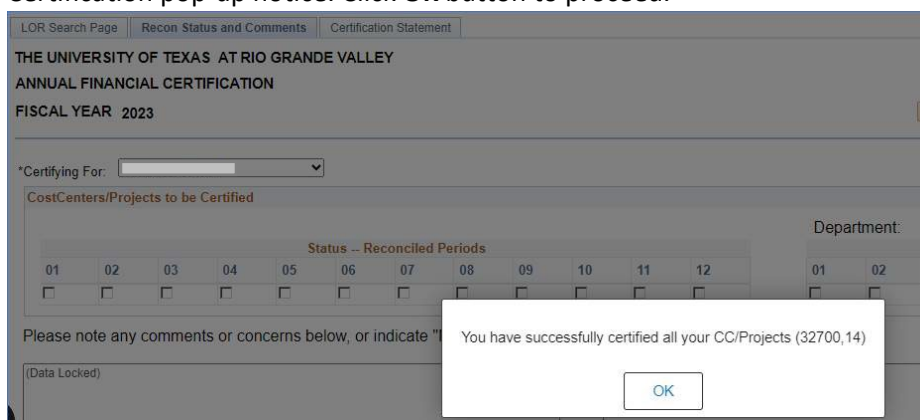
13. You now have the option to exit the Annual Certification screen and coordinate with the Reconciler to Reconcile the missing periods before you can resume with the Monthly Approval process. When the monthly process is complete for all missing reconciliations, you may then return to the Annual Certification to finalize the certifications pending. However, you may proceed to the next step if your intentions are to certify with outstanding reconciliations (that is not our recommendation). Additionally, if you forgot to add comments earlier, please take this time to go back to the previous tab (Recon Status and Comments) to add and save your comment(s).

14. To submit and lock the Certification, click on the **SAVE CERTIFICATION** button. All options are now LOCKED.
