- Adding a 15-credit hour certificate that will include clinical hours that are required, so the nurses can sit on the certification exam and be certified nationally, then to the board of the State of Texas.
- ♣ Dr. Hansmann: On the letter of recommendation which poses a barrier for students and the Graduate College is under the impression that the letter of recommendation was going to be removed, but I still see it there.
- ♣ Dr. Rojas: it was discussed and taken into consideration however, it has been changed to being specifically assigned to it being a professional recommendation.
- → Dr. Hansmann: The Graduate College, thinks that is fine. imperative. that is your preference, but what needs to be understood is that anybody who's applying right now for the intention of getting this right now does have to present that or they cannot graduate in May.
- Dr. John VandeBurg: Does the motion pass if almost everyone on the board abstains?
 - **.** Dr. Hansmann:
 - If the majority of members abstain on a measure, the measure fails.
 - Recusals change the approval from a majority to a majority of a quorum.

- You do not lose quorum because you initially had quorum, if a member walks out for recusal.

1. Announcement regarding Joint Committee Meeting (Undergraduate & Graduate Curriculum Committees) on March 27, 2020. Location and time are TBA

♣ Dr. Hansmann:

- ➤ The University is having more programs combined bachelor's, master's type programs unified degree plans, the 4 + 1
- > SACSCOC requires to have joint meeting that includes both grad and undergrad members to hear those types of request.
- It is a formative meeting for the two committees to get together and decide how to go about it. For example, will this meeting take place once or twice a semester? Will it be a subcommittee or as a whole?
- Meeting will take place on Friday in the early morning (2hr)
- Approval of certain programs are approved internally or externally
 - o For example, minor changes to degree plans, things that are not considered standard can be approved at the institutional level, except for changes to admission criteria those have to go through the UT System for approvals and they meet twice a year and they notify the coordinating boards and they meet twice a year.
 - Any type of new minor which are 18 hours or greater goes through internal approvals, system approvals and coordinating board approvals.
 - The addition of any certificates that are 16 hours or more goes through internal approvals, system approvals and coordinating board approvals.
 - Any new master's programs or PhD programs or any engineering program, regardless of level has to go through internal approvals, system approvals and coordinating board approvals.
 - o Graduate Catalog
 - > Students that begin on the catalog year they started when there are committed that will be their catalog year.
 - ➤ If the degree plan doesn't change will not affect the student but if the degree plan changes the student can finish the degree plan as planned or they can voluntarily change to the new degree plan.
 - ➤ We cannot change a catalog that is in existence. For example, we want to change the degree plan for Spring. The answer is No.
