RESEARCH

My research centers on the relationship between ethnic and other identities in early medieval Europe and the Mediterranean and the ways these strategies of identification contributed to the development of new kingdoms and states. My 2017 monograph explored textual clues from sixth- and seventh-century Gaul and Spain of the shift that led Romans to adopt the Frankish and Gothic identities of their new rulers. My current book project, *The Afterlife of Gothic Identity: Religion, Ethnicity, and Legitimacy in Early Medieval Iberia*, extends this exploration into the eighth through tenth centuries, examining how Gothic identity changed, and was put to specific uses, in Iberia immediately following the Islamic conquest. I have also co-edited and contributed to a volume on inclusion and exclusion in the late antique and early medieval Mediterranean, and contributed to publications on medieval origin legends, local identities, and the Roman legacy in Visigothic Iberia.
