These contributions help improve the quality of life for people in communities locally, across the country and around the world.

UTRGV Human Resources coordinates The State Employee Charitable Campaign during the month of October. All pledge forms must be submitted by October 31, 2024.

# 5. What charities/organizations are involved?

One of the great benefits of the SECC is the wide variety of charities and causes represented — there's something for everyone. They range from small local organizations to large and well-known statewide, national, and international groups.

Those charities that wish to participate must meet stringent legal requirements, and then be reviewed in detail by teams of state employees to ensure:

- They are recognized by the IRS as 501(c)(3) nonprofit organizations and registered with the Secretary of State.
- They are audited (or reviewed) annually by an accountant in accordance with generally accepted auditing standards.
- They provide direct or indirect health and human services.
- They spend no more than 25 percent of funds raised on administration and fund raising unless they qualify for an exception due to special circumstances.
