FINANCIAL INFORMATION

For I-20 issuance purposes, the estimated minimum student expenses for 2021-2022 are listed below. The information below is valid for one year from signature. Estimates include tuition and fees for one academic year and 12 months of living expenses. Summer tuition is not included (add amounts in the gray column if beginning in summer). **The cost of tuition is subject to change without notice.** When computing your expenses, remember that you should not expect employment as a means of support unless an offer of an academic appointment (teaching or research assistantship) accompanies graduate admission. Although proof of funding is required for the first year only, you are expected to fund your studies for the duration of the degree program. Financial aid is generally not available to new international students, and financial assistance to continuing students is limited

HEALTH INSURANCE: F-1 students enrolled at the University are required to have medical insurance that is compliant with the Patient Protection and Affordable Care Act at a Gold Level or higher. For this reason, enrollment in the UT Student Health Insurance Plan is automatic for non-Mexican nationals at the time of registration, and the cost of the policy is included in the student's tuition and fee bill.

REQUIRED DOCUMENTATION OF FUNDS:

- An official dated bank statement must be provided (checking or savings accounts)
- Statement must include the account holder's name, date, account type, account balance and currency type.
- All accounts must be easily accessible and in liquid assets
- If sponsored by employer, submit official letter from sponsor's employer on company letterhead
- All documents must be in English or Spanish
- All supporting documentation must be dated within six (6) months of initial enrollment
- Letters of sponsorship (scholarship/fellowship/assistantship verification form) must include exact dollar amount of support (in U.S. dollars) and dates covered
- If you are bringing dependents, you must prove your ability to provide an additional \$4000 for spouse and \$2000 per children per year. **NOTE: Credit cards, life insurance, business bank accounts, retirement and/or pension funds are not acceptable. Please determine your estimated expenses:**
