

*"Between Migrant Struggles and Control. The Spatial Production of Migratory Corridors across the Americas."*



## **Soledad Álvarez Velasco, PhD**

Assistant Professor

Departments of Anthropology and Latin  
American & Latino Studies

Dr. Soledad Álvarez Velasco, a distinguished social anthropologist and human geographer with a PhD in Human Geography from King's College London, is renowned for her groundbreaking research on migration dynamics across the Americas. Her work explores undocumented global south-north and south-south migration, border regimes, and migratory corridors, utilizing multi-sited and digital ethnography to reconstruct migrant trajectories.

Focusing on the Andean Region, Dr. Álvarez Velasco examines migration routes from Latin America, the Caribbean, Africa, and Asia, while addressing topics such as the externalization of U.S. border policies, unaccompanied migrant children, and transnational smuggling networks.

She has held academic positions at the University of Heidelberg, the University of Houston, and is currently an Assistant Professor at the University of Illinois Chicago, where she teaches courses on migration, border regimes, and mobility across the Americas.

We are honored to welcome Dr. Álvarez Velasco to our conference, where she will offer valuable insights into the complexities of contemporary migration.

**Luis H. Zayas, Ph.D.**

Provost and Senior Vice President for Academic Affairs

Luis H. Zayas has served as Provost and Senior Vice President for Academic Affairs at the University of Texas Rio Grande Valley (UTRGV) since June 2023.

Originally from Coamo, Puerto Rico, Dr. Zayas earned his bachelor's degree in Economics and Liberal Arts from Manhattan College, followed by a Master of Social Work and a Ph.D. in Developmental Psychology from Columbia University. Before joining UTRGV, he was the Dean of the Steve Hicks School of Social Work at UT Austin and a Distinguished Professor at Washington University in St. Louis.

His research, funded by the National Institutes of Health (NIH), focuses on the psychosocial well-being of immigrant families and the mental health of Latina adolescents. He is the author of books such as *Through Iceboxes and Kennels* (2023) and *Forgotten Citizens* (2015).

Additionally, he has served as an expert witness in immigration policy litigation, providing insights into the psychological effects of deportation and family separation.

In November 2024, Dr. Zayas was honored with the Dr. José A. Ruiz-Escalante Award by the Texas Association for Bilingual Education (TABE) for his leadership and contributions to bilingual education in higher education.

## Border Tour - On February 21st 1:45 - 5:30 p.m.

Join Stefanie Herweck and Scot Nicol, co-authors of two ACLU reports on the impacts of the U.S. - Mexico border wall, for a virtual tour of the border and border walls in the Rio Grande Valley. The tour will include a discussion of impacts of the walls on migrants, communities, businesses, farms, and natural areas, as well as an update on the ongoing construction of walls under the Biden Administration.



The US-Mexico border is most frequently imagined by people outside the border region as either a static geographical boundary or a zone of conflict and contention.
