#### FINANCIAL INFORMATION

<u>HEALTH INSURANCE</u>: F-1 students enrolled at the University are required to have medical insurance that is compliant with the Patient Protection and Affordable Care Act at a Gold Level or higher. For this reason, enrollment in the UT Student Health Insurance Plan is automatic for non-Mexican nationals at the time of registration, and the cost of the policy is included in the student's tuition and fee bill.

#### **REQUIRED DOCUMENTATION OF FUNDS:**

- An official dated bank statement must be provided (checking or savings accounts)
- The statement must include the account holder's name, date, account type, account balance, and currency type.
- All accounts must be easily accessible and in liquid assets
- If sponsored by an employer, submit an official letter from the sponsor's employer on company letterhead
- All documents must be in English or Spanish
- All supporting documentation must be dated within six (6) months of initial enrollment
- Letters of sponsorship (scholarship/fellowship/assistantship verification form) must include the exact dollar amount of support (in U.S. dollars) and dates covered
- If you are bringing dependents, you must prove your ability to provide an additional \$4000 for your spouse and \$2000 per child per year. NOTE: Credit cards, life insurance, business bank accounts, retirement, and/or pension funds are not acceptable. Please determine your estimated expenses:
