_____ **Submission of a Criminal Background Check:** You are responsible for obtaining a criminal background check (CBC) through to DISA Healthcare Technology (formerly CastleBranch). You will be asked to complete this national criminal background check no sooner than **March 01, 2026**, and no later than **July 01, 2026**. Regardless of any information disclosed during the admissions process, admission is contingent upon receiving a CBC showing no felony convictions and/or other serious violations described under OTHER within the [Admissions Education Requirement](#).

_____ **Submission of a Drug Screen:** You are responsible for obtaining a drug screening through DISA Healthcare (formerly CastleBranch). You will be asked to complete this screening no later than **30 days before the first day of Orientation**.

_____ **Satisfaction of all Immunization Requirements:** You are responsible for submitting all required immunizations as found in the [SOPM Student Handbook](#). Proof of immunizations signed by an authorized health care provider must be uploaded to your CastleBranch account. Documents must be in English and include your full name, date of birth, UTRGV student ID, medical school level (PMS1), and your graduation class (Class of 2030). This must be done no later than 30 days before the first day of Orientation.
