 - Phase III longitudinal research only at UT Austin
 - Key Challenge for UTRGV: students and employees knowing where to go for help

- Texas Legislation is reviewing bills that will affect Higher Education's response and handling of sexual misconduct issues
- o Mr. Mike James Employee Appraisal Program
 - Evaluation Period: May 1-April 30
 - Explained rating: 3 = competent in performing job; 4=occasionally exceed;
 5=consistently exceed; process is subjective
 - Development plans can be issued to any employee at any rating level since the goal is to further develop
 - E-signature capable now that doesn't require printing of the forms
 - Substantive changes made are to the weight of the factors, affect the overall score
 - Training sessions are available
