Who are we? The Office for Victim Advocacy and Violence Prevention (OVAVP) works with students, staff, and faculty, and community partners to strive for a campus free from gender-based and interpersonal violence and to facilitate services for victims and survivors of sexual assault, domestic violence, dating violence, stalking, sexual harassment, and interpersonal violence.

ALL SERVICES PROVIDED BY OVAVP ARE FREE AND CONFIDENTIAL. Let me share some of the information we share with students:

The Continuum of Force: Examples of different behaviors

Identify these behaviors

- Typical things partners do
- Not OK, but Not Sexual Violence
- Sexual Violence

No Right or Wrong Answer

The Continuum of Force

- Interpersonal Violence can sometimes be difficult to identify and process.
- Remember there are no right or wrong responses
- Interpersonal Violence can eb sexual, emotional, physical, or economical.
- Interpersonal Violence can be very difficult subject to discuss and easy to minimize or ignore.

National Statistics

- Approximately 1 in 15 children are exposed to intimate partner violence each year.
- Approximately 1 in 5 women are sexually assaulted during their college tenures.
- Most instances of sexual assault are perpetrated by someone the victim knows or is acquainted with.
- Intimate partner physical abuse has declined almost 70% since the passage of the Violence Against Women Act in 1994.

Confidential & Client - Centered

What does it mean to be confidential?

- Anything that is disclosed will not be reported to University Officials
- Anything that is disclosed will not be reported to Law Enforcement
- Advocates will not disclose any information without consent from the client

Exceptions: Confidentiality may be broken in instances of imminent threat to self or others, or if there is suspected abuse or neglect of a child, elder, or person with a debilitating disability.

OVAP provides services to staff also.

Who we serve?

- Our office is open to all currently enrolled students, faculty, and staff at The University of Texas Rio Grande Valley (UTRGV)
- Domestic/dating violence (DV) and sexual assault (SA) do not discriminate. Anyone can be subject to violence victimization, regardless of gender, color, disability, sexual orientation, ethnicity, religion, size, social economic status or level of education.
- Our doors are open to any UTRGV affiliate who seeks our services.
