The campus needs other projects that were on HOLD? The perfect Question, for next Segway in our presentation.

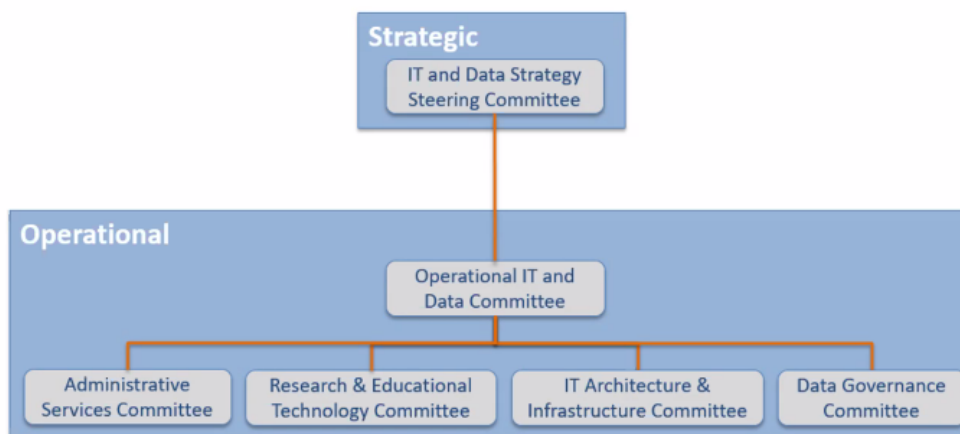

Organization



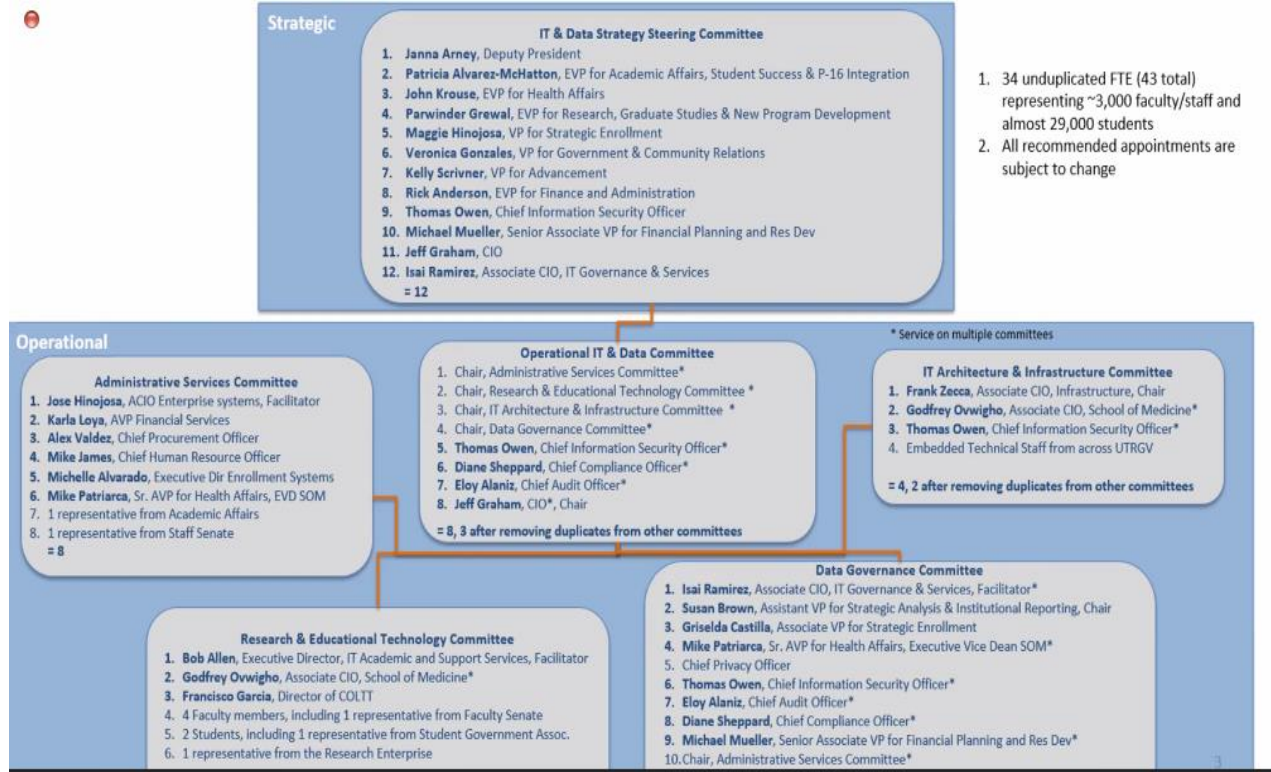
Left side is the administrative owners. They are responsible for setting priorities

Data Governance – where do we store data and definitions

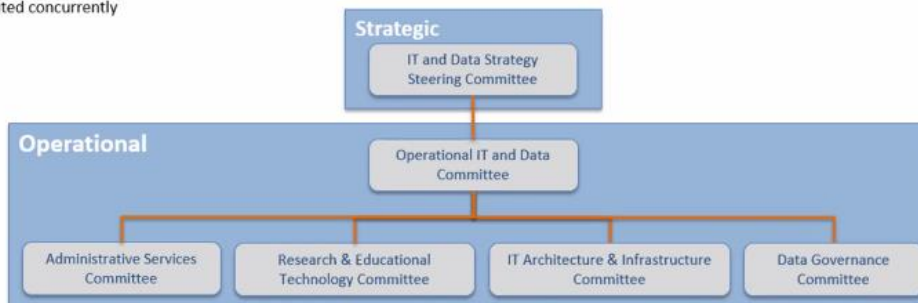

1st order of business will be to submit their chairs by July and the group will be getting organized.

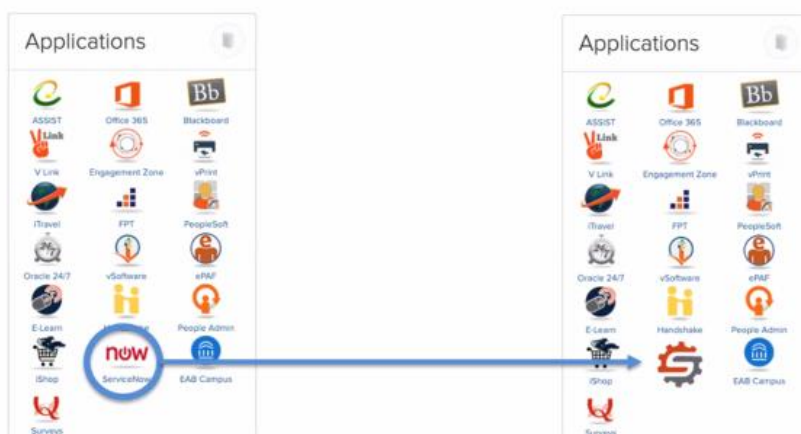
By August to be functional

SECTION 4: TERM OF OFFICE

1. The term of office for members shall begin at a special meeting to be called by September 1, following their election and shall continue for one elected three-year term. Terms shall be staggered so that approximately one-third of the membership is elected each year.
2. A member shall not be eligible for reelection to the Staff Senate in the year following the expiration of the member's three-year term.
3. In the event a representative is appointed to represent the Staff Senate on a special committee (i.e. Employee Advisory Council) and the committee assignment exceeds the remainder of the representative's term, the term shall be extended to the end date of the committee assignment.

Rebekha is requesting a motion to remove the line from the constitution. so we would not extend anyone's term taking a spot from a user.

Robert and Nicole feel like it is a good fit, to keep them hooked to report back to the senate and to hear our concerns.

Michael, part of the thought was continuity

Rebekah, Gilbert the EAC doesn't have to be a staff senator

Gilbert, at the EAC most of the EAC are not staff senators.

PJ recommends to define what a special committee – define

Rebekah motions to remove line 3 because we do not have a definition of what a special committee at this time.
