- a. Dr. Cynthia Jones Director of Advocacy and Violence Prevention (OVAP)
   Florence Nocar Director, Title IX and Equal Opportunity
   Key Points:
  - Provided an overview of OVAP's confidential services for staff, faculty, and students, including support for domestic/dating violence, stalking, harassment, and other violence-related issues.
  - ii. Clarified that OVAP is the only fully confidential resource on campus (with exceptions only for state-mandated reporting).
  - **iii.** Highlighted the office's training initiatives, bilingual support, and collaboration with other university departments.

# The University of Texas Rio Grande Valley Staff Senate

- iv. Shared that new QR code posters will be placed in restrooms to discreetly connect individuals with resources.
- v. Promoted the annual CAVE conference taking place September 4-5, 2025 at the SAS Building.
- vi. Explained the responsibilities of the Title IX Office in handling sexual misconduct and discrimination complaints.
- vii. Clarified the role of mandatory reporters under Texas Senate Bill 212 and emphasized that reports must be submitted directly to the Title IX Office.
- viii. Discussed reporting process, privacy vs. confidentiality, and provided guidance on how to handle disclosures compassionately.
- ix. Stressed that failure to report could result in termination and legal consequences.
- x. Encouraged faculty/staff to notify OVAP first if unsure whether something is reportable.

**Key Points:** 

- i. Introduced upcoming UT Health RGV Imaging Center at the new Cancer and Surgery Center in McAllen.
- ii. Provided overview of diagnostic services to be offered:
  - 1. MRI with Al-assisted speed and noise reduction
  - 2. CT, PET-CT, Ultrasound, Mammography, X-Ray, Bone Density, and ABUS.

- iii. Announced soft opening on August 4, 2025 (initially for Medicare and self-pay patients due to CMS certification process).
- iv. Clarified which procedures will not be available at launch (e.g., FDG PET, breast/prostate MR biopsies).
- v. Provided contact information for further inquiries and referrals.
